# **Building Enclosure Nears Completion**

Above ceiling mechanical, electrical, and plumbing (MEP) installation activities continue and will be followed by wall framing. The precast installation is substantially complete at the main building. Curtain wall and punch window installation continues and will be completed in January, followed by the installation of the storefront at the base of the building. The special rigging of MEP equipment continues and will be performed intermittently in January and February. The rigging of the balance of the MEP equipment to the roof will occur during normal hours and off hours on Saturdays, as needed.

The demobilization of the tower cranes will begin in January with the removal of Tower Crane East. This is scheduled to be complete in February. Demobilization of Tower Crane West will require the closure of Sixth Street. Details for the Sixth Street closure, as well as the timing and duration of the closure, will be communicated via a separate notice. The demobilization of the tower crane equipment will require multiple trucks during the week.

The logistics on Sixth Street continue to be implemented and will remain in place for the duration of the project. This includes the 105 foot staging area at the corner of Sixth Street and Eighth Avenue. The volume of truck deliveries continues to increase as the fit-out phase of the project is well underway, with the installation of multiple MEP systems, framing, etc.

Installation by Con Edison in the building network protector rooms will begin in January as construction of the network protectors is complete. The Sixth Street Carrington/ Revocable Consent trench work continues at the Carrington side of the street. Weather permitting, this work will be in complete in February. Work for construction of the new CCH loading dock at Fifth Street continues. Concrete placement at the loading dock

continues and requires temporary closure of sidewalk and parking spaces at Fifth Street during scheduled concrete pour days. Existing ductwork has been modified to allow for the continued construction of this area. The installation of the precast facade requires the closure of Fifth Street and is scheduled to occur during the weekend of 1/19 or 1/26. Road closure notices have been posted and distributed to the residents of Fifth Street. A separate notice will be sent out when the dates are confirmed. Completion of concrete work in this area will follow the precast installation.
