Building Enclosure is Complete

The building is now enclosed. Above ceiling mechanical, electrical, and plumbing (MEP) installation activities continue and will be followed by wall framing. Curtain wall and punch window installation is substantially complete, and the installation of beauty caps ongoing. Storefront installation has begun and will be complete in mid-February. Metal panel screen wall/rain screen installation has also commenced at the top of the building. The rigging of MEP equipment is complete.

The demobilization of the tower cranes has commenced and is scheduled to be complete in February. Demobilization of the west tower crane requires the closure of Sixth Street, which is scheduled to take place from Thursday, 2/21 through Sunday, 2/24. Demobilization of the tower crane equipment will require multiple trucks during this operation, as well as extended work hours as needed.

The logistics on Sixth Street continue to be implemented and will remain in place for the duration of the project. This includes the 105 foot staging area at the corner of Sixth Street and Eighth Avenue. The volume of truck deliveries continues to increase as the fit-out phase of the project is well underway, with the installation of multiple MEP systems, framing, etc.

Installation by Con Edison in the building network protector rooms began in early February. A completion schedule Con Edison is yet to be communicated. Permanent power from Con Edison is required by early March to facilitate the energizing of the building and temporary cooling required for finishes.

The Sixth Street Carrington/ Revocable Consent trench work continues at the Carrington side of the street. The walkway will be restored in February. The driveway will remain closed until installation of the traffic coating is

complete. Traffic coating installation is weather permitting and is expected to be completed in the spring.

Work for construction of the new CCH loading dock at Fifth Street continues. Precast panel installation at the loading dock was successfully completed in mid-January. Concrete placement continues at the elevated loading dock slab.

Work at the existing hospital for installation of systems related to the CCH building is also ongoing.
