



Dear Medicaid Provider,

The New York Department of Health (DOH) has partnered with the medical record review abstraction firm, **MedReview Inc.** to conduct medical record collection and abstractions for all PPS' participating in **Delivery System Reform Incentive Payment (DSRIP) Domains 2 and 3.** Your practice has been selected through a randomized sampling methodology to participate. It is imperative we have your cooperation in this important endeavor.

The medical record review will require the abstraction of data to population six HEDIS measures (controlling high blood pressure, comprehensive diabetes care, prenatal and postpartum care, frequency of ongoing prenatal care, childhood immunization status, and lead screening in children) and two State-developed non-HEDIS measures (screening for clinical depression and viral load suppression). The specific items needed for each measure are listed in the attached document. The MedReview scheduling team will be contacting providers who have five or more members in the sample to schedule a site visit for record collection and review. These visits must be scheduled and completed by November 1, 2015.

If your office has fewer than five members in the sample, we are asking that you please provide the requested information (outlined in the attached document) to us no later than **October 16th, 2015** by either:
