

## New York- Presbyterian PPS Newsletter

Dear New York- Presbyterian PPS members,

On May 21, the NYP PPS executed the award letter and formally agreed to move forward as a DSRIP PPS. Since that time we have submitted the required Implementation Plan, which is under review by the Independent Assessor (IA). To date, we have not been notified of any deficiencies in the submission with the IA's feedback shortly. On July 1 the State released the DSRIP Quarterly Report format and we have begun preparing our submission for the period of April 1 through June 30, 2015. The report is due by July 31 and will show the progress our PPS has made so far. At the same time, the individual DSRIP project groups are finalizing their specific Project Implementation Plans, which will also be submitted to the Department of Health on July 31.

### **New York State Updates**

#### DSRIP News

On June 18 in New York City the Department of Health held a meeting for all PPSs from across the State. At the meeting the IA presented on Domain 2 - 4 Achievement Values (AVs). Achievement Values are the points given for achieving milestones in a given reporting period for Domains 1 - 4. A June 29 webinar covers how those AVs relate to DSRIP payment calculations. The IA staff also provided an overview of their expectations related to the structure, required documentation and work plan reporting that will make up the quarterly reports.

## Capital Restructuring Financing Program Update

As you know DOH and the Dormitory Authority of the State of New York announced a reissuance of the availability of funds under the Capital Restructuring Financing Program (CRFP) in early April. In reissuing the CRFP procurement, DOH did not change the application form or attachments and encouraged PPSs to resubmit their original applications along with a letter of attestation if the resubmission was going to be identical to the original submission. We resubmitted an "identical" application and are now awaiting the State's response. Unofficially we have been told that the State's response will be in the September/October time frame but there has been no formal communication regarding a date. ## PPS Committee Updates

The Executive, Clinical Operations, IT/Data Governance and Finance Committees have all been meeting on a monthly basis with co-chairs chosen, committee charters approved and the overall governance structure ratified by the Executive Committee. The Committees are now focused on working through the respective organizational requirements that were included in the DSRIP application and Implementation Template. In addition the PPS PAC held its quarterly meeting on June 15.
